



Our role in the commercial passenger vehicle industry

We regulate:

- max. fares for <u>unbooked</u> commercial passenger vehicle services
- the maximum non-cash payment surcharge
- the commercial passenger vehicle trip levy.

The Parliament has **not** given us a role to regulate:

- fares for booked commercial passenger vehicle services
- taxi drivers' income
- fares in the country zone.

Unbooked taxi fare review 2022: Our role

- We review maximum fares every two years
- Our current price determination was made in September 2020
- The new max. fares will apply from 1 October 2022 (or earlier)

What we heard from stakeholders:

- Maximum fares should increase
- Driver shortages and high fuel prices are affecting the supply of taxi services
- Preference for unbooked taxi fares to be deregulated

Note: the fuel prices we used include the full fuel excise tax

Unbooked taxi fare review 2022: Draft decision

Maximum fares will increase by 10.4 per cent

- change in fuel costs: 6 per cent
 change in driver labour costs: 4.3 per cent
- \$5 increase for a trip from the CBD to the airport
 \$1 increase for a 3km trip within the CBD
- same level of increase for high occupancy vehicle trips

Increase in maximum fares may change in the final decision

We propose a fare adjustment mechanism

- Given high fuel prices, stakeholders suggest that we include a variability mechanism in our fare setting approach
- This would allow fares to increase or decrease in between reviews, if needed
 - only based on changes in fuel and driver labour costs, above an agreed threshold (e.g., +/- one per cent)
- We are seeking your views on our proposal including the most appropriate threshold to trigger a fare adjustment

Unbooked taxi fare review 2022: Our approach

- New taxi cost index
 - informed by a cost survey
 - gives regard to recent amendments to the legislation on the commercial viability of operating a taxi and the Fair Work Commission's annual wage review
- Balance of demand and supply
 - demand has improved but supply is currently constrained due to a shortage of drivers
- Stakeholder feedback

Our draft decision meets our objectives

- Our draft decision will:
 - enable operators to recover the efficient costs of providing unbooked taxi services
 - help attract new drivers
 - facilitate continued service provision to consumers.
- We also seek your feedback on the length of time required to update meters and replace stickers.

We are open to an earlier effectivity date for the new maximum fares.
