1. Where a new non-residential lot is created, that is 50mm water connection or greater, the New Customer Contributions (water, sewer and recycled water) payable will be the multiple of the applicable New Customer Contribution and the number of equivalent 20mm connections.

2. Where lot sizes are less than 300 metres square, the applicable Other Areas NCC prices will apply.

3. This fee will be collected over 5 years (paid quarterly) from the time that customers are declared to be serviced. South East Water will offer customers a reduced fee of \$525 per lot contribution (collected at \$75 per quarter over 2 years) if customers agree to connect within the first two years of being notified that a connection is available.
